2. Understanding AODA & ACA Requirements

Under AODA and ACA, public-facing documents must:

- Be readable by screen readers
- Include proper tagging structure (headings, lists, tables, etc.)
- Provide alt-text for images
- Be navigable and searchable
- Avoid scanned images of text without OCR

Non-compliance can result in:

- Fines and penalties
 - Legal risk
 - Public backlash
 - Missed opportunities to serve your entire community
